# DUTIES OF A SPECIAL (ACTING) CONSTABLE

A Special Constable is expected to put in at least three hours of training/street duty per week, and more if the needs of the city dictate.

A Special Constable may at need be put on duty by a watch officer of the rank of Corporal or above, in addition, when emergency dictates, he may place himself on duty.

A Special may purchase his own equipment, but if it is considerably superior to that of serving officers he shouldn't flash it around. In addition, he should not carry so much equipment that he cannot move above a walk.

A Special is advised that remembering he's off shift in ten minutes and legging it just as the mob closes in will **not** earn him the respect of his surviving full-time colleagues.

A Special need **not** wear his uniform in bed.

### POWERS OF ARREST

All citizens have de facto powers of arrest in two circumstances, which may be summarised as:

### HE WAS DOING IT or HE JUST DONE IT AND I SAW IM!

Officers of the Watch, including Acting Constables, also have powers of arrest in two further circumstances:

I SUSPECTED HE WAS GOING TO DO IT, SIR, DEFINITELY IT AND I SUSPECT HE DONE IT ALL RIGHT!

### **COMMON STREET OFFENCES**

A useful common-law offence, but officers resorting to it should remember that they will have to cite two (2) personally or generally known incidents to substantiate bad un and must have studied the chart of funny looks available in all Watch Houses. They must also have consulted the register of citizens who, through no fault of their own, look funny all the time.

# AN AIDE MEMOIRE FOR THE CONSTABLE AND WATCHMAN

### Riot:

Riot is the tumultuous disturbance of the peace by three or more persons, being any specie, sub specie, or alleged specie, who assemble together of their own authority against any who oppose them in the execution of an enterprise of a private nature, and afterwards actually execute the same in a violent and turbulent manner to the terror of the people in order to have a bit of a laugh.

The modern short form that has been found to work just as well in practice is:



### FIRST AID
